TERMS OF SERVICE

Definitions

Teampaper websites' refers primarily to all domains owned by the Teampaper corporation.

'File' refers to any document that has the potential to be uploaded to Teampaper websites.

'User' refers to the individual who visit Teampaper websites, has uploaded files to Teampaper websites, or accesses files from Teampaper websites.

'URL' refers to the location of any file located on Teampaper' servers.

File uploading

User is not allowed to upload anything that can be remotely construed as porn, copyrighted material, harassment, or spam. The following types of files constitute "abuse" and may not be uploaded under any circumstances:

1. Pornographic files. This includes, but is not limited to, files depicting genitalia, nudity, or sexual situations.
2. Files that are illegal and/or are in violation of any United States laws.
3. Files that infringe on the copyrights of any entity excluding the user.
4. Non-image or non-video files. This includes archived non-image files.
5. Files intending to harass or spam, or promote anything for commercial profit.
6. Pornography, adult or mature content.
7. Violent content.
8. Content related to racial intolerance or advocacy against any individual, group or organisation.
9. Excessive profanity.
10. Hacking/cracking content.
11. Illicit drugs and drug paraphernalia content.
12. Sales of beer or hard alcohol.
13. Sales of tobacco or tobacco-related products.
14. Sales of prescription drugs.
15. Sales of weapons or ammunition (e.g. firearms, firearm components, fighting knives, stun guns).

16. Sales of products that are replicas or imitations of designer or other goods.
17. Sales or distribution of coursework or student essays.
18. Content regarding programs which compensate users for clicking ads or offers, performing searches, surfing websites or reading emails.
19. Any other content that is illegal, promotes illegal activity or infringes on the legal rights of others.

Privacy

All personal information provided by the user is strictly confidential. Teampaper reserves the right to distribute aggregated demographic information provided by the user, but Teampaper will never release any personal information about the user without permission. However, Teampaper reserves the right to release user information if user has violated the Teampaper Terms of Service, if the user has committed unlawful acts, if the information is subpoenaed, or if Teampaper deems it necessary or appropriate.
